

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (BEAUVALE CRESCENT AREA, HUCKNALL)  
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (4306)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Hucknall in the District of Ashfield: -

1. Proposed prohibition of **Waiting At Any Time** along the following length of road: -

**ABBOTS ROAD, HUCKNALL** (the east side)

- From its junction with Beauvale Road in a southerly direction for 10 metres.

**ABBOTS ROAD, HUCKNALL** (the west side)

- From a point 10 metres north of its junction with Beauvale Crescent in a southerly direction to a point 10 metres south of that junction.
- From its junction with Beauvale Road in a southerly direction for 10 metres.

**BEAUVALE CRESCENT, HUCKNALL** (the north side)

- From its junction with Abbots Road in a westerly direction for 10 metres.

**BEAUVALE CRESCENT, HUCKNALL** (the north-east side)

- From a point 17 metres north-west of its junction with Beauvale Road in a south-easterly direction to a point 10 metres south-east of that junction.

**BEAUVALE CRESCENT, HUCKNALL** (the south side)

- From its junction with Abbots Road in a westerly direction for 10 metres.

**BEAUVALE CRESCENT, HUCKNALL** (the south-west side)

- From a point 10 metres north-west of its junction with Springfield Road in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 2 metres north-west of its junction with Hillcrest Drive in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 10 metres north-west of its junction with Laxton Drive in a south-easterly direction to a point 10 metres south-east of that junction

**BEAUVALE ROAD, HUCKNALL** (the north-west side)

- From its junction with Beauvale Crescent in a north-easterly direction for 6 metres.

**BEAUVALE ROAD, HUCKNALL** (the south-east side)

- From its junction with Beauvale Crescent in a north-easterly direction for 10 metres.

**BEAUVALE ROAD, HUCKNALL** (the south-west side)

- From a point 10 metres north-west of its junction with Abbots Road in a south-easterly direction to a point 5 metres south-east of that junction.

**HILLCREST DRIVE, HUCKNALL** (both sides)

- From its junction with Beauvale Crescent in a south-westerly direction for 10 metres.

**LAXTON DRIVE, HUCKNALL** (both sides)

- From its junction with Beauvale Crescent in a southerly direction for 10 metres.

**SPRINGFIELD ROAD, HUCKNALL** (both sides)

- From its junction with Beauvale Crescent in a south-westerly direction for 10 metres.

2. Other Restrictions:- Proposed **Bus Stop Clearway – No Stopping at any time except buses** on the following length of road:

**BEAUVALE CRESCENT, HUCKNALL** (the south-west side)

- From a point 17 metres north-west of its junction with Hillcrest Drive in a south-easterly direction for 15 metres.

**BEAUVALE CRESCENT, HUCKNALL** (the south side)

- From a point 56 metres west of its junction with Abbots Road in an easterly direction for 19 metres.

**BEAUVALE ROAD, HUCKNALL** (the north-west side)

- From a point 21 metres north-east of its junction with Beauvale Crescent in a south-westerly direction for 15 metres.
