

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (WEST STREET AND WOOD LANE AREA,  
HUCKNALL) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (4307)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Hucknall in the District of Ashfield: -

1. Proposed **prohibition from Waiting At Any Time** along the following length of road: -

**CHARLES STREET, HUCKNALL** (both sides)

- From its junction with West Street in a southerly direction for 10 metres.

**SANDY LANE, HUCKNALL** (both sides)

- From its junction with West Street in a south-westerly direction for 10 metres.

**SPRING STREET, HUCKNALL** (both sides)

- From its junction with West Street in a northerly direction for 10 metres.

**TURNER STREET, HUCKNALL** (both sides)

- From its junction with West Street in a south-westerly direction for 5 metres.

**WEST STREET, HUCKNALL** (the north side)

- From a point 10 metres west of its junction with Spring Street in an easterly direction to a point 10 metres east of that junction.

**WEST STREET, HUCKNALL** (the south side)

- From its junction with Sandy Lane in an easterly direction for 10 metres.

**WEST STREET, HUCKNALL** (the south-west side)

- From a point 10 metres north-west of its junction with Charles Street in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 5 metres north-west of its junction with Turner Street in a south-easterly direction to a point 10 metres south-east of that junction.

**WOOD LANE, HUCKNALL** (the south-east side)

- From its junction with Sandy Lane in a south-westerly direction for 10 metres.

2. Vehicles will be **prohibited from Waiting between 7am and 7pm** along the following length of road:

**WEST STREET, HUCKNALL** (the south side)

- From a point 10 metres east of its junction with Sandy Lane in an easterly direction to a point 67 metres east of that junction.

3. Other Restrictions:- **Bus Stop Clearway – No Stopping 7am-7pm except buses** on the following length of road:

**WOOD LANE, HUCKNALL** (the north-west side)

- From a point 40 metres south-west of its junction with North Hill Avenue in a south-westerly direction for 19 metres.

**WOOD LANE, HUCKNALL** (the south-east side)

- From a point 10 metres south-west of its junction with Sandy Lane in a south-westerly direction for 19 metres.
