

THE NOTTINGHAMSHIRE COUNTY COUNCIL (HIGH STREET AREA, HUTHWAITE)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2026 (4325)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Huthwaite in the District of Ashfield: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

HIGH STREET, HUTHWAITE

(the north side)

- From a point 10 metres west of its junction with Johns Hill in an easterly direction to a point 10 metres east of that junction.
- From its junction with North Street in a westerly direction for 10 metres.
- From its junction with Unwin Street in an easterly direction for 10 metres.

(the south side)

- From its junction with North Street in a westerly direction for 10 metres.
- From its junction with Unwin Street in an easterly direction for 10 metres.

JOHNS HILL, HUTHWAITE (both sides)

- From its junction with High Street in a northerly direction for 10 metres.

NORTH STREET, HUTHWAITE (the west side)

- From a point 46 metres north of its junction with High Street in a southerly direction to a point 10 metres south of that junction.

UNWIN STREET, HUTHWAITE (the east side)

- From a point 10 metres north of its junction with High Street in a southerly direction to a point 10 metres south of that junction.
