

**Road Traffic Regulation Act 1984**

**The Nottinghamshire County Council (Nottingham Road, Rycroft Street and Wadsworth Road Area, Stapleford) (Prohibition of Waiting) Traffic Regulation Order 2017 (5239)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Stapleford in the Borough of Broxtowe: -

1. Vehicles will be prohibited from waiting At Any time along : -

ARTHUR AVENUE, STAPLEFORD (both sides)

- From its junction with Wadsworth Road in a south-westerly direction for a distance of 28 metres

CHARLES AVENUE, STAPLEFORD (both sides)

- From its junction with Wadsworth Road in an south-westerly direction for a distance of 28 metres

NOTTINGHAM ROAD, STAPLEFORD (the north side)

- From a point 10 metres south-west of its junction with Rycroft Street in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with Wadsworth Road in an north-easterly direction to a point 10 metres north-east of that junction

RYCROFT STREET, STAPLEFORD (both sides)

- From its junction with Nottingham Road in a northerly direction for a distance of 15 metres

WADSWORTH ROAD, STAPLEFORD (the east side)

- From its junction with Nottingham Road in a northerly direction for a distance of 15 metres

WADSWORTH ROAD, STAPLEFORD (the west side)

- From its junction with Nottingham Road in a northerly direction for a distance of 15 metres
- From a point 10 metres south-east of its junction with Arthur Avenue in a north-westerly direction to a point 9 metres north-west of that junction
- From a point 10 metres south-east of its junction with Charles Avenue in a north-westerly direction to a point 8 metres north-west of that junction
