

**Road Traffic Regulation Act 1984**

**The Nottinghamshire County Council (Eastwood Road / Glenfield Road / Lawn Mill Road / Jubilee Street and Truman Street, Kimberley) (Prohibition of Waiting) Traffic Regulation Order 2019 (5269)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Kimberley in the Borough of Broxtowe: -

1. Vehicles will be prevented from waiting At Any Time at the junctions of the following: -

**EASTWOOD ROAD** (the north-east side)

- from a point 6 metres north-west of its junction with Truman Street in a south-easterly direction to a point 5 meters south-east of that junction
- from a point 6 metres north-west of its junction with Jubilee Street in a south-easterly direction to a point 5 meters south-east of that junction

**GLENFIELD AVENUE** (the south-west side) –

- from its junction with Truman Street in a north-westerly direction for 5 metres

**LAWN MILL ROAD** (the south-west side) –

- from its junction with Truman Street in a south-easterly direction for 5 metres
- from a point 5 metres north-west of its junction with Jubilee Street in a south-westerly direction to a point 7 meters south-east of that junction

**JUBILEE STREET** (both sides) (measured along the centre line of the road)

- from its junction with Lawn Mill Road in a south-westerly direction for 7 metres
- from its junction with Eastwood Road in a north-easterly direction for 8 metres

**TRUMAN STREET, (both sides)** (measured along the centre line of the road)

- from its junction with Lawn Mill Road in a south-westerly direction for 5 metres
- from its junction with Eastwood Road in a north-easterly direction for 6 metres
