

**Road Traffic Regulation Act 1984**

**The Nottinghamshire County Council (Eskdale Drive, Medway Close and Warkton Close, Chilwell)  
(Prohibition of Waiting and No Stopping on Entrance Clearways) Traffic Regulation Order 2019 (5281)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Chilwell in the Borough of Broxtowe: -

1. Vehicles will be prohibited from waiting At Any Time along the following: -

**ESKDALE DRIVE, CHILWELL**

- (the north side and north-east side) from a point opposite its junction with Medway Close in an easterly then south-easterly direction to a point 27 metres north-west of its junction with Warkton Close
- (the south side and south-west side) - from a point 13 metres west of its junction with Medway Close in an easterly then south-easterly direction to a point 27 metres north-west of its junction with Warkton Close
- (the south-west side) - from a point 10 metres north-west of its junction with Warkton Close in a south-easterly direction to a point 8 metres south-east of that junction
- (the south-east side) - from a point 10 metres west of its junction with Firbank Court in an easterly direction to a point 18 metres north-east of that junction

**FIRBANK COURT, CHILWELL** (both sides)

- From its junction with Eskdale Drive in a south-easterly direction for 10 metres

**MEDWAY CLOSE, CHILWELL** (both sides)

- From its junction with Eskdale Drive in a south-easterly direction for 11 metres

**WARKTON CLOSE, CHILWELL** (both sides)

From its junction with Eskdale Drive in a south-westerly direction for 10 metres

2. Vehicles will be prohibited from stopping on school entrance markings on Monday to Friday between 8am and 4.30pm at the following locations: -

**ESKDALE DRIVE, CHILWELL**

(the north side)

- From a point opposite a point 18 metres north-east of its junction with Firbank Court in a north-easterly direction for 52 metres.
- From a point opposite a point 13 metres south-west of its junction with Medway Close in a south-westerly direction for 37 metres.

(the south side)

- From a point 18 metres north-east of its junction with Firbank Court in a north-easterly direction for 52 metres.
- From a point 13 metres south-west of its junction with Medway Close in a south-westerly direction for 37 metres.

The no waiting restriction is required to keep one side of the road clear for vehicles to pass safely. The no stopping restrictions are to be applied to the school keep clear markings outside the school to prohibit stopping during the school day.
