

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Dunster Road and Peters Close, Newthorpe) (Prohibition of Waiting) Traffic Regulation Order 2021 (5294)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Newthorpe in the Borough of Broxtowe: -

1. Vehicles will be prohibited from waiting **At Any Time** along: -

DUNSTER ROAD, NEWTHORPE

(the south-east side)

- From a point 15 metres south-west of its junction with Peters Close in a north-easterly direction to a point 10 metres north-east of that junction

PETERS CLOSE, NEWTHORPE (both sides)

- From its junction with Dunster Road in a south-easterly direction for 10 metres

2. Vehicles will be prohibited from waiting **Mon - Fri 8 am – 4.30pm** along:

DUNSTER ROAD, NEWTHORPE

(the south-east side)

- From a point 77 metres north-east of its junction with Peters Close in a north-easterly then easterly then north-easterly then north-westerly direction to the point where it meets the north-west side of Dunster Road (the turning head)

(the north-west side)

- From a opposite a point 77 metres north-east of its junction with Peters Close in a north-easterly direction for 18 metres

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall libraries are closed or if reopened will have restrictions in place.

The restrictions are required to prevent unsafe and obstructive parking around the junction and in the turning head.
