

**The Nottinghamshire County Council (A6007 Ilkeston Road,  
New Access Road and Rowan Avenue, Stapleford) (Prohibition of  
Waiting) Traffic Regulation Order 2021 (5299)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Stapleford in the Borough of Broxtowe:-

1. Vehicles will be prohibited from waiting **At Any Time** along: -

**ILKESTON ROAD, STAPLEFORD** (the north side)

- From a point opposite a point 100 metres south-east of its junction with Rowan Avenue in a north-westerly direction to a point opposite a point 68 metres north-west of that junction

**ILKESTON ROAD, STAPLEFORD** (the south side)

- From a point 100 metres south-east of its junction with Rowan Avenue in a north-westerly direction to a point 49 metres north-west of that junction

**NEW ACCESS ROAD** (both sides)

- From its junction with Ilkeston Road in a northerly direction 10 metres

**ROWAN AVENUE, STAPLEFORD** (both sides)

- From its junction with Ilkeston Road in a southerly direction 12 metres

2. Other restrictions: - **Bus Stop Clearway** – No Stopping At Any Time, except Buses

**ILKESTON ROAD, STAPLEFORD** (south side)

**Bus Stop RU 0082** – from a point 49 metres north-east of its junction with Nottingham Road in a north-easterly direction for 19 metres

As a result of the impact of COVID-19 and in accordance with Public Health England's advice on social distancing and avoiding non-essential trips, public buildings such as County Hall libraries are closed or if reopened will have restrictions in place.
