

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Canal Side, Cornwall Avenue, Riverside Road, Trent Road and Trent Vale Road, Beeston Rylands (Prohibition of Waiting) Traffic Regulation Order 2022 (5307)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Beeston in the Borough of Broxtowe: -

1. Vehicles will be prohibited from **waiting at any time** along: -

CANAL SIDE, BEESTON
(the north-west side)

- From a point opposite its junction with Cornwall Avenue in a southerly then south-easterly direction for 39 metres
- From a point 15 metres north-east of its junction with Trent Road in a south-westerly direction to a point 15 metres south-west of that junction

(the south-east side)

- From its junction with Cornwall Avenue in a southerly then south-easterly direction for 46 metres

CORNWALL AVENUE, BEESTON (the south-east side)

- From its junction with Canal Side in a north-easterly direction for 8 metres

TRENT ROAD, BEESTON (both sides)

- From its junction with Canal Side in a north-westerly direction for 10 metres

2. Vehicles will be prohibited from **waiting Monday to Saturday 7am – 7 pm** along: -

CANAL SIDE, BEESTON (the south-east side)

- From a point opposite a point 15 metres north-east of its junction with Trent Road in a south-westerly direction to a point opposite a point 15 metres south-west of that junction

RIVERSIDE ROAD, BEESTON (the north-west side)

- From a point 12 metres south-west of its junction with South Road in a south-westerly direction for 217 metres

3. Other restrictions: - **Bus Stop Clearways** – No Stopping Monday to Saturday 7am - 7 pm, except Buses

RIVERSIDE ROAD, BEESTON (south-west side) Bus Stop BR0282

- from a point 21 metres north of its junction with Johns Road in a south-easterly direction for 19 metres

TRENT ROAD, BEESTON (north-west side) Bus Stop BR0580

- from a point opposite a point 3 metres south-west of its junction with Trent Road (cul-de-sac section) in a south-easterly direction for 19 metres

TRENT VALE ROAD, BEESTON (south-east side) Bus Stop BR0283

- from a point 58 metres south-west of its junction with Trent Road in a south-westerly direction for 19 metres
