

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (CORNFIELD ROAD AREA, KIMBERLEY)**  
**(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2022 (5321)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Kimberley in the Borough of Broxtowe: -

Vehicles will be prohibited from **Waiting At Any Time** along the following lengths of road: -

**Alma Hill, Kimberley** (the south-west side)

- From a point 11 metres north-west of its junction with Cornfield Road in a south-easterly direction to a point 10 metres south-east of that junction.

**Almond Close, Kimberley** (the north-east side)

- From its junction with Cornfield Road in a south-easterly direction for 12 metres.

**Almond Close, Kimberley** (the south-west side)

- From its junction with Cornfield Road in a south-easterly direction for 12 metres.

**Cornfield Road, Kimberley** (the north-west side)

- From its junction with Alma Hill in a south-westerly direction for 9 metres.
- From a point 7 metres north-east of its junction with Ruislip Close in a south-westerly direction to a point 7 metres south-west of that junction.

**Cornfield Road, Kimberley** (the south-east side)

- From its junction with Alma Hill in a south-westerly direction for 9 metres.
- From a point 12 metres north-east of its junction with Almond Close in a south-westerly direction to a point 12 metres south-west of that junction.

**Ruislip Close, Kimberley** (the north-east side)

- From its junction with Cornfield Road in a north-westerly direction for 7 metres.

**Ruislip Close, Kimberley** (the south-west side)

- From its junction with Cornfield Road in a north-westerly direction for 7 metres.
