

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (ALLISON GARDENS AREA, CHILWELL)  
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (5330)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Chilwell in the Borough of Broxtowe: -

Vehicles will be **prohibited from Waiting At Any Time** along the following lengths of road: -

**Allison Gardens, Chilwell**

(the north-east side)

- From its junction with Bye Pass Road in a north-westerly direction for 17 metres.
- From its junction with High Road in a south-easterly direction for 16 metres

**Allison Gardens, Chilwell**

(the south-west side)

- From its junction with Bye Pass Road in a north-westerly direction to a point 11 metres north-west of its junction with Ruskin Avenue.
- From its junction with High Road in a south-easterly direction for 17 metres.

**Bye Pass Road, Chilwell**

(the north-west side)

- From a point 13 metres south-west of its junction with Allison Gardens in a north-easterly direction to a point 11 metres north-east of that junction.

**High Road, Chilwell**

(the south-east side)

- From a point 10 metres south-west of its junction with Allison Gardens in a north-easterly direction to a point 12 metres north-east of that junction.

**Ruskin Avenue, Chilwell**

(the north-west side)

- From its junction with Allison Gardens in a southerly direction for 11 metres.

**Ruskin Avenue, Chilwell**

(the south-east side)

- From its junction with Allison Gardens in a south-westerly direction for 11 metres.
