

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (MEADOW ROAD AREA, BEESTON)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (5353)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Beeston in the Borough of Broxtowe: -

1. Vehicles will be **Prohibited from Waiting** along the following lengths of road: -

APPLETON ROAD, BEESTON

(the east side)

- From its junction with Meadow Road in a southerly direction for 10 metres

(the west side)

- From its junction with Meadow Road in a southerly direction for 10 metres

(the north-east side)

- From its junction with Canal Side in a north-westerly direction for 10 metres

(the south-west side)

- From its junction with Canal Side in a north-westerly direction for 10 metres

CANAL SIDE, BEESTON (the north-west side)

- From a point 10 metres south-west of its junction with Appleton Road in a north-easterly direction to a point 10 metres north-east of that junction

CORNWALL AVENUE, BEESTON (the north-west side)

- From its junction with Meadow Road in a north-easterly direction for 10 metres

ELSWICK DRIVE, BEESTON

(the east side)

- From its junction with Meadow Road in a northerly direction for 12 metres

(the west side)

- From its junction with Meadow Road in a northerly direction for 9 metres

LOCKWOOD CLOSE, BEESTON (both sides)

- From its junction with Meadow Road in a north-easterly direction for 12 metres

LONGLANDS ROAD, BEESTON (both sides)

- From its junction with Meadow Road in a south-westerly direction for 10 metres

MEADOW ROAD, BEESTON

(the north side)

- From a point 12 metres west of its junction with Elswick Drive in an easterly direction to a point 13 east of that junction

(the north-east side)

- From a point 10 metres north-west of its junction with Roy Avenue in a south-easterly direction to a point 10 metres south-east of that junction

- From a point 12 metres north-west of its junction with Lockwood Close in a south-easterly direction to a point 15 metres south-east of that junction

- From a point 12 metres north-west of its junction with Suffolk Avenue in a south-easterly direction to a point 21 metres south-east of that junction

- From its junction with Cornwall Avenue in a north-westerly direction to a point 12 metres

(the south-west side)

- From a point 10 metres north-west of its junction with Longlands Road in a south-easterly direction to a point 10 metres south-east of that junction

(the south side)

- From a point 10 metres east of its junction with Appleton Road in a westerly direction to a point 10 metres west of that junction

ROY AVENUE, BEESTON (both sides)

- From its junction with Meadow Road in a north-easterly direction for 10 metres

SUFFOLK AVENUE, BEESTON (both sides)

- From its junction with Meadow Road in a north-easterly direction for 13 metres
