

THE NOTTINGHAMSHIRE COUNTY COUNCIL (BALDWIN STREET, MAIN STREET AND STAMFORD STREET, NEWTHORPE) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (5354)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Newthorpe in the Borough of Broxtowe: -

1. Proposed **No Waiting At Any Time** along the following lengths of road: -

BALDWIN STREET, NEWTHORPE

(the north-east side)

- From its junction with Stamford Street in a north-westerly direction for 9 metres (the south-west side)
 - From its junction with Stamford Street in a north-westerly direction for 10 metres

MAIN STREET, NEWTHORPE (the south-west side)

• From a point 6 metres north-west of its junction with Stamford Street in a south-easterly direction to a point 10 metres south-east of that junction

STAMFORD STREET, NEWTHORPE

(the east side)

- From its junction with Main Street in a south-westerly direction for 10 metres (the west side)
 - From its junction with Main Street in a south-westerly direction for 10 metres
 - From a point 6 metres north of its junction with Baldwin Street in a southerly direction to a point 7 metres south of that junction
