

THE NOTTINGHAMSHIRE COUNTY COUNCIL (CHAPEL STREET AREA, BRAMCOTE) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (5362)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Bramcote in the Borough of Broxtowe: -

Proposed prohibition from Waiting At Any Time along the following length of roads: -

<u>Chapel Mews Court, Bramcote</u> (west side)

• From its junction with Chapel Street in a northerly direction for 10 metres.

Chapel Street, Bramcote (north side)

 From its junction with Town Street in an easterly direction to the western side of Chapel Mews Court.

<u>Chapel Street</u>, <u>Bramcote</u> (south side)

• From its junction with Town Street in an easterly direction for 27 metres.

Town Street, Bramcote (north-east side)

- From a point 10 metres north-west of its junction with Chapel Street in a south-easterly direction to a point 12 metres south-east of that junction.
- 2. Proposed **Bus Stop Clearway (No Stopping at any time except buses)** along the following lengths of road:-

<u>Town Street</u>, <u>Bramcote</u> (north-east side)

• From a point 59 metres south-east of its junction with Chapel Street in a north-westerly direction for 19 metres.

<u>Town Street</u>, <u>Bramcote</u> (south-west side)

• From a point opposite a point 52 metres south-east of its junction with Chapel Street in a in a south-easterly direction for 19 metres.
