STOKE LANE, STOKE BARDOLPH – PROPOSED 40MPH SPEED LIMIT AND NO U TURN RESTRICTION – PUBLIC CONSULTATION

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing to introduce a 40mph speed limit on Stoke Lane between the end of the existing 40mph speed limit to the start of the existing 30mph speed limit. The new speed limit would replace the existing National Speed Limit (60mph). The length of road covered by the new speed limit would include the existing entrances to the water treatment works and the new entrance into the employment development located opposite. The new limit will help to reduce the speed of traffic approaching the existing 30mph speed limit.

In addition to the new speed limit it is proposed to introduce a U turn ban on Trent Valley Way (A612), at the Stoke Lane junction, for vehicles travelling in a north-easterly direction towards Burton Joyce. The ban will help to make the junction safer by removing this potential dangerous manoeuvre. Vehicles wanting to make a U turn at this junction is likely to increase as the secondary entrance into the new housing development, off Trent Valley Way, will be left turn only.

The introduction of the proposed speed limit would involve replacing the existing National Speed Limit signs with 40mph signs at the existing site near the Top Row houses. The existing signs outside the New Works Cottages would be removed completely. The no U turn signs would be incorporated into the traffic lights at the junction of Trent Valley Way and Stoke Lane.

The above proposals are in response to the new housing developments that are to be built to both sides of Trent Valley Way (A612).

Before proceeding further with the proposed restrictions, I wish to consider the views of residents and organisations who may be interested in this matter. Suggestions will be incorporated in the proposal wherever appropriate and economically feasible. If your comments are in the form of an objection to the proposals and if they cannot be resolved, they will be reported through the County Council's procedures at the appropriate time. Any observations on these proposals should reach me by **4th August 2017**
