

**THE NOTTINGHAMSHIRE COUNTY COUNCIL**  
**(CORONATION ROAD AREA, WOODTHORPE) (PROHIBITION OF WAITING)**  
**TRAFFIC REGULATION ORDER 2023 (7267A)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Woodthorpe in the Borough of Gedling: -

Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

**Breck Hill Road, Woodthorpe** (both sides)

- From a point 10 metres south-east of its junction with Coronation Road in a north-westerly direction to a point 10 metres north-west of that junction.

**Bonington Road, Woodthorpe** (both sides)

- From its junction with Coronation Road in a south-easterly direction for 10 metres.

**Coronation Road, Woodthorpe** (north-west side)

- From a point 10 metres south-west of its junction with Breck Hill Road in a north-easterly direction to a point 10 metres north-east of that junction

**Coronation Road, Woodthorpe** (south-east side)

- From a point 10 metres south-west of its junction with Breck Hill Road in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 10 metres south-west of its junction with Bonington Road in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 10 metres south-west of its junction with Gretton Road in a north-easterly direction to a point 5 metres north-east of that junction.

**Gretton Road, Woodthorpe** (both sides)

- From its junction with Coronation Road in a south-easterly direction for 10 metres.
