

THE NOTTINGHAMSHIRE COUNTY COUNCIL
(VARIOUS ROADS, GEDLING) (PROHIBITION OF WAITING)
TRAFFIC REGULATION ORDER 2023 (7271)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Gedling in the Borough of Gedling: -

1. Vehicles will be **prohibited from Waiting At Any Time** along the following lengths of road: -

Arnold Lane, Gedling (the north-east side)

- From a point 10 metres north-west of its junction with Jessops Lane in a south-easterly direction to a point 10 metres south-east of that junction.
- From its junction with Wykes Avenue in a north-westerly direction for a distance of 10 metres.

Brooklands Drive, Gedling (both sides)

- From its junction with Shearing Hill in a south-westerly direction for 10 metres.

Coronation Walk (south-west to north-east section), Gedling (the south-east side)

- From a point 12 metres south-west of Coronation Walk Link Road in a north-easterly direction to a point 12 metres north-east of that junction.

Coronation Walk Link Road, Gedling (both sides)

- From its junction with Burton Road in a north-westerly direction to its junction with Coronation Walk (South-East Section).

Jessops Lane, Gedling (both sides)

- From its junction with Arnold Lane in a north-easterly direction for 15 metres.

Shearing Close, Gedling (both sides)

- From its junction with Shearing Hill in a north-easterly direction for 10 metres.

Shearing Hill, Gedling (north-east side)

- From a point 10 metres north-west of its junction with Shearing Close in a south-easterly direction to a point 10 metres south-east of that junction.

Shearing Hill, Gedling (south-west side)

- From a point 10 metres north-west of its junction with Brooklands Drive in a south-easterly direction to a point 10 metres south-east of that junction.

Wykes Avenue, Gedling (both sides)

- From its junction with Arnold Lane in a north-easterly direction for 10 metres.

2. Other Restrictions:- **Bus Stop Clearway – No Stopping At Any Time** on the following length of road:

Arnold Lane, Gedling (the north-east side)

- From its junction with Wykes Avenue in a south-easterly direction for 19 metres.
