

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (FURLONG STREET AREA, ARNOLD)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (7273)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Arnold in the Borough of Gedling: -

Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

Acton Road, Arnold (both sides)

- From its junction with Furlong Street in a north-westerly direction for 10 metres.

Bestwood Avenue, Arnold (north-east side)

- From its junction with Furlong Street in a north-westerly direction for 11 metres.

Bestwood Avenue, Arnold (south-west side)

- From its junction with Furlong Street in a north-westerly direction for 10 metres

Burford Street, Arnold (both sides)

- From its junction with Furlong Street in a south-easterly direction for 10 metres.

Cavendish Street, Arnold (both sides)

- From its junction with Furlong Street in a south-easterly direction for 10 metres.

Furlong Avenue, Arnold (both sides)

- From its junction with Furlong Street in a north-westerly direction for 10 metres.

Furlong Street, Arnold (north-west side)

- From a point 10 metres south-west of its junction with Acton Road in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 10 metres south-west of its junction with Bestwood Avenue in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 13 metres south-west of its junction with Furlong Avenue in a north-easterly direction to a point 10 metres north-east of that junction.

Furlong Street, Arnold (south-east side)

- From a point 10 metres south-west of its junction with Burford Street in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with Cavendish Street in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with High Street Avenue in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with West Street in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of a private access (between properties no 10 and 16a Furlong Road) in a north-easterly direction to a point 10 metres north-east of that private access.

High Street Avenue, Arnold (north-east side)

- From its junction with Furlong Street in a south-easterly direction for 10 metres.

High Street Avenue, Arnold (south-west side)

- From its junction with Furlong Street in a south-easterly direction for 11 metres.

West Street, Arnold (north-east side)

- From its junction with Furlong Street in a south-easterly direction for 11 metres.

West Street, Arnold (south-west side)

- From its junction with Furlong Street in a south-easterly direction for 12 metres.
