

## <u>THE NOTTINGHAMSHIRE COUNTY COUNCIL</u> (DARLTON DRIVE AREA, ARNOLD) (PROHIBITION OF WAITING) <u>TRAFFIC REGULATION ORDER 2024 (7274)</u>

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Arnold in the Borough of Gedling: -

Proposed prohibition of Waiting At Any Time along the following lengths of road: -

## Darlton Drive, Arnold(north-east side)

- From a point 10 metres north-west of its junction with Farm Road in a south- easterly direction to a point 10 metres south-east of that junction.
- From a point 10 metres north-west of its junction with Langford Road in a south- easterly direction to a point 10 metres south-east of that junction.

## Darlton Drive, Arnold (south-west side)

• From a point 10 metres north-west of its junction with Saunby Close in a south- easterly direction to a point 10 metres south-east of that junction.

## Farm Road, Arnold (east side)

- From its junction with Darlton Drive in a northerly direction for 13 metres.
- Farm Road, Arnold (west side)
  - From its junction with Darlton Drive in a northerly direction for 14 metres.

Langford Road, Arnold (both sides)

- From its junction with Darlton Drive in a northerly direction for 15 metres.
- Saunby Close, Arnold (east side)
- From its junction with Darlton Drive in a southerly direction for 10 metres. **Saunby Close, Arnold** (west side)
  - From its junction with Darlton Drive in a southerly direction for 11 metres.
