

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Epperstone Road Area, West Bridgford) (Prohibition of Waiting and Residents' Controlled Zone) Traffic Regulation Order 2017 (8263)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at West Bridgford in the Borough of Rushcliffe: -

1. To provide residents' parking places operating All days 10 am to 8pm along Epperstone Road and part of George Road, West Bridgford
2. To provide 2 hours parking, no return within 1 hour. Operating Mon to Sat 8am - 6pm along:-
George Road
(north side) - from a point 10 metres east of its junction with Musters Road in an easterly direction for a distance of 22 metres
(south side) - from a point 10 metres east of its junction with Musters Road in an easterly direction for a distance of 10 metres
from a point 30 metres east of its junction with Musters Road in an easterly direction for a distance of 14 metres
Musters Road (east side) - from a point 15 metres south of its junction with George Road in an southerly direction for a distance of 30 metres
- from a point 55 metres south of its junction with George Road in an southerly direction for a distance of 10 metres
Patrick Road (north side) - from a point 15 metres east of its junction with Musters Road in an easterly direction for a distance of 58 metres
Patrick Road (south side) - from a point 15 metres east of its junction with Musters Road in an easterly direction for a distance of 16 metres
- from a point 41 metres east of its junction with Musters Road in an easterly direction for a distance of 32 metres
3. Vehicles will be prevented from waiting at any time along:-
Patrick Road (south side) - From a point 31 metres east of its junction with Muster Road for a distance of 10 metres
Epperstone Road (west side) - From a point 43 metres south of its junction with Patrick Road for a distance of 23 metres
George Road (north side) - from a point 32 metres east of its junction with Musters Road in an easterly direction for a distance of 11 metres
(South side) - from a point 20 metres east of its junction with Musters Road in an easterly direction for a distance of 10 metres

Written objections (stating grounds and quoting ref. **8263**) must be received by me by **22nd day of December 2017**.

The provision is required to improve parking facilities for residents by removing non-residential parked vehicles from Epperstone Road and George Road and to provide short stay parking on George Road, Patrick Road and Musters Road.
