

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Various Roads in Ruddington) (Prohibition of Waiting) Traffic Regulation Order 2019 (8282)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Ruddington in the Borough of Rushcliffe: -

1. Vehicles will be prevented from waiting At Any Time along:-

Camelot Street

(north side)

- from its junction with Templeman Close in a westerly direction for 31 metres
- from a point 81 metres west of its junction with Templeman Close in a westerly then northwesterly direction for 16 metres

(north-east side) - from a point 6 metres north of its junction with Camelot Crescent in a south-easterly direction to a point 6 metres south-east of that junction

(west and south side) -

- from a point 10 metres north of its junction with Samson Court in a south-easterly direction to a point 10 metres south-east of that junction
- from a point 10 metres north-west of its junction with Shelton Gardens in a south-easterly then easterly direction for 58 metres

(south side) - from its junction with Clifton Road in a northerly then westerly direction for 23 metres

Mere Way

(east side) - from a point opposite a point 10 metres north-east of the entrance (northern kerb line) to the Heritage Centre in a southerly direction for 200 metres

(north-west side) - from its junction (the outer perimeter of roundabout) with Loughborough Road in a south-westerly direction for 182 metres

(the south-east side)

- from its junction (the outer perimeter of roundabout) with Loughborough Road in a southwesterly direction for 83 metres
- from a point 10 metres north-east of its entrance to Britannia House in a south-westerly direction to a point opposite a point 10 metres north-east of the entrance to the Heritage Centre
- from a point 10 metres south-east of its entrance to Ergo House in a north-easterly direction to a point 10 metres north-east of that junction

- from a point 48 metres south-east of its entrance to Ergo House in a north-easterly direction for 26 metres
- From a point 14 metres south of its entrance to Discovery House in a northerly direction for 30 metres
- From a point 17 metres south of its entrance to Honda Phase 3 Building in a northerly direction for 35 metres

(the south-west side) - from a point 10 metres north-east of its entrance to Fairham House in a south-easterly direction to a point 10 metres south-east of that junction

(the west side)

- from a point 10 metres north of its entrance to the Heritage Centre in a southerly direction to a point 52 metres north of the entrance to the Sherwood House
- from a point 10 metres north of its entrance to Sherwood House in a southerly direction to a point 43 metres north of the southern driveway from 'Greene Tweed & Co Ltd'
- from a point 50 metres north-west of its north-eastern entrance to Fairham House in a south-easterly direction for 26 metres

(the east, south-east and west side (inner perimeter) - from the give way line outside Emtec Building in a clockwise direction around the entire inner perimeter to the same point (an approximate distance of 605 metres)

Samson Court (both sides) - from its junction with Camelot Street in a westerly direction for 10 metres

Shelton Gardens (both sides) - from its junction with Camelot Street in a westerly direction for 10 metres

Templeman Close (west side) - from its junction with Camelot Street in a westerly direction for 14 metres

The Avenue (both sides) - from its junction with Mere Way in a south-easterly direction for 95 metres
