

Road Traffic Regulation Act 1984

**The Nottinghamshire County Council (Cotgrave Country Park Area)
(Prohibition of Waiting) Traffic Regulation Order 2021 (8319)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Cotgrave in the Borough of Rushcliffe: -

1. Vehicles will be prohibited from waiting **At Any Time** along: -

HARVEST DRIVE, COTGRAVE

- (the north-east side) From its junction with Hollygate Lane in a north-westerly direction for 19 metres
- (the south-west side) From its junction with Hollygate Lane in a north-westerly direction for 25 metres

HOLLYGATE LANE, COTGRAVE

(the north-west side)

- From its junction with the roundabout in a south-westerly direction for 36 metres
- From a point 15 metres north-east of its junction with Harvest Drive in a south-westerly direction to a point 15 metres south-west of that junction
- From a point 32 metres south-west of its junction with Harvest Drive in a south-westerly direction for 25 metres

(the south-east side)

- From its junction with the roundabout in a south-westerly direction for 40 metres

MAIN ROAD, COTGRAVE (the north-east side)

- From a point 14 metres south-east of its junction with Mill Lane in a north-westerly direction to a point 20 metres north-west of that junction

MAYGREEN AVENUE, COTGRAVE

(the north-east side)

- From its junction with the roundabout in a north-westerly direction for 36 metres

(the south-west side)

- From its junction with the roundabout in a north-westerly direction for 34 metres

MILL LANE, COTGRAVE

(the north-west side)

- From its junction Main Road in a north-easterly direction for 12 metres (measured along the centre line)
- From a point 87 metres north-east of its junction Main Road in a north-easterly then northerly direction for 47 metres

(the south-east side)

- From its junction Main Road in a north-easterly direction for 12 metres (measured along the centre line)
- From a point 87 metres north-east of its junction Main Road in a north-easterly then northerly direction for 58 metres

2. Other restrictions: - **Bus Stop Clearway** – No Stopping At any time

HARVEST DRIVE, COTGRAVE (the south-west side)

- From a point 25 metres north-west of its junction with Hollygate Lane in a north-westerly direction for 19 metres

HOLLYGATE LANE, COTGRAVE

(the north-west side)

- From a point 54 metres north-east of its junction with Harvest Drive in a north-easterly direction for 19 metres

(the south-east side)

- From a point 73 metres south-west of its junction with the roundabout in a south-westerly direction for 19 metres
