

**Road Traffic Regulation Act 1984**

**The Nottinghamshire County Council (Park Avenue, West Bridgford)  
(Amendments to Residents' Controlled Zone) Traffic Regulation Order  
2022 (8328)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at West Bridgford in the Borough of Rushcliffe: -

**Park Avenue, West Bridgford**

1. To extend the times of the existing Residents Parking scheme from Monday to Saturday, 8am – 8pm to **At Any Time**
2. To provide residents parking places at the following:
  - from a point 20 metres south of its junction with Bridgford Road in a south-westerly direction for 27 metres
  - from a point 53.5 metres south of its junction with Bridgford Road in a south-westerly direction for 22 metres
  - from a point 80 metres south of its junction with Bridgford Road in a south-westerly direction for 12 metres
  - from a point 96.5 metres south of its junction with Bridgford Road in a south-westerly direction for 11.5 metres
