

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (ROADS IN THE VICINITY OF ABINGDON ROAD, CYRIL ROAD AND STAMFORD ROAD, WEST BRIDGFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (8340)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at West Bridgford in the Borough of Rushcliffe: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

## Abbey Road, West Bridgford (the west side)

• From a point 10 metres north of its junction with Abingdon Road in a southerly direction to a point 10 metres south of this junction.

# Abingdon Road, West Bridgford (the north side)

- From its junction with Oxford Road in an easterly direction for 10 metres.
- From its junction with Abbey Road in a westerly direction for 10 metres.

### Abingdon Road, West Bridgford (the south side)

- From its junction with Oxford Road in an easterly direction for 10 metres.
- From its junction with Abbey Road in a westerly direction for 10 metres.

## Cyril Road, West Bridgford (the east side)

• From a point 10 metres north of its junction with Davies Road in a southerly direction to a point 10 metres south of this junction.

#### Cyril Road, West Bridgford (the west side)

• From a point 10 metres north of its junction with Davies Road in a southerly direction to a point 10 metres south of this junction.

# <u>Davies Road, West Bridgford</u> (the north side)

• From a point 10 metres east of its junction with Cyril Road in a westerly direction to a point 10 metres west of this junction.

#### **Davies Road, West Bridgford** (the south side)

• From a point 10 metres east of its junction with Cyril Road in a westerly direction to a point 10 metres west of this junction.

# Oxford Road, West Bridgford (the north-east side)

• From a point 10 metres north-west of its junction with Abingdon Road in a south-easterly direction to a point 10 metres south-east of this junction.

### Rufford Way, West Bridgford (the east side)

• From its junction with Stamford Road in a northerly direction for 20 metres.

# Rufford way, West Bridgford (the west side)

• From its junction with Stamford Road in a northerly direction for 20 metres.

#### Stamford Road, West Bridgford (the north-west side)

• From a point 20 metres north-east of its junction with Rufford Way in a south-westerly direction to a point 20 metres south-west of this junction.
