

Road Traffic Regulation Act 1984

The Nottinghamshire County Council (Burrows Drive, Dunsmore Avenue, Henshaw Drive, Penson Gardens, Widnall Drive and Wright Mews, Bingham) (Prohibition of Waiting and Entrance Clearways) Traffic Regulation Order 2022 (8345)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Bingham in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Waiting At Any Time** along the following: -

BURROWS DRIVE (BINGHAM) (the north-east side)

- From its junction with Henshaw Drive in a south-easterly direction for 10 metres

DUNSMORE AVENUE (BINGHAM) (the north-east side)

- From a point 10 metres north-west of its junction with Penson Gardens in a south-easterly direction to a point 9 metres south-east of that junction.
- From a point 7 metres north-west of its junction with Unnamed Road in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 10 metres north-west of its junction with Wright Mews in a south-easterly direction to a point 10 metres south-east of that junction

HENSHAW DRIVE (BINGHAM) (both sides)

- From its junction with Widnall Drive in a north-easterly direction for 10 metres

PENSON GARDENS (BINGHAM) (both sides)

- From its junction with Dunsmore Avenue in a north-easterly direction for 10 metres

UNNAMED ROAD (BINGHAM) (both sides)

- From its junction with Dunsmore Avenue in a north-easterly direction for 10 metres

WIDNALL DRIVE (BINGHAM) (the north-east side)

- From its junction with Henshaw Drive in a north-westerly direction for 10 metres

WRIGHT MEWS (BINGHAM) (both sides)

- From its junction with Dunsmore Avenue in a north-easterly direction for 10 metres

2. Vehicles will be **Prohibited from Waiting Mon – Fri 8am 4.30pm** along the following: -

BURROWS DRIVE (BINGHAM) (the north-east side)

- From a point 10 metres south-east of its junction with Henshaw Drive in a south-easterly direction for 93 metres
- From a point 22 metres south-east of the centre line of the school vehicle entrance in a south-easterly direction for 49 metres (the south-west side)
- From a point opposite a point 62 metres south-east of its junction with Henshaw Drive in a south-easterly direction for 84 metres

DUNSMORE AVENUE (BINGHAM)

(the north-east side)

- From a point 10 metres south-east of its junction with Unnamed Road in a south-easterly direction for 26 metres
- From a point 10 metres south-east of its junction with Wright Mews in a south-easterly direction for 41 metres (the south-west side)
- From a point opposite the north-west kerb line of Unnamed Road in a north-easterly direction for 29 metres
- From a point opposite a point 10 metres north of the north-west kerb line of Wright Mews in a south-westerly direction for 21 metres

3. To prohibit **stopping** on school entrance markings **Monday to Friday between 8am and 4.30pm** at the following locations:-

BURROWS DRIVE (BINGHAM)(the north-east side)

- From a point 21.5 metres north-west of the vehicle entrance to the school in a south-easterly direction for 43 metres

DUNSMORE AVENUE (BINGHAM)(the south-west side)

- From a point opposite a point 10 metres north-west of the north-western kerb line Wright Mews in a north-westerly direction for 43 metres

4. Other restrictions: - **Bus Stop Clearway** – No Stopping At Any Time Except buses

DUNSMORE AVENUE (BINGHAM)

(the north-east side)

- From a point 9 metres south-east of its junction with Penson Gardens in a south-easterly direction for 52 metres (the south-west side)
- From a point opposite a point 7 metres south-east of its junction with Wrights Mews in a south-easterly direction for 45 metres
