BINGHAM ROAD, RADCLIFFE ON TRENT – PROPOSED BUS STOP CLEARWAYS AND DOUBLE YELLOW LINES (TRO 8349) – PUBLIC ADVERT

Via East Midlands Ltd, working on behalf of Nottinghamshire County Council, is proposing that the following locations below are now being formalised as enforceable marked bus stop clearways and are shown on the attached site notices and drawing H/SLW/4098/01: -

BINGHAM ROAD, RADCLIFFE ON TRENT – NO STOPPING AT ANY TIME, EXCEPT BUSES

- **(RU0586)** - Outside numbers 90 and 92 – (15 metre clearway)
- **(RU0587)** - Outside numbers 81 and 83 – (19 metre clearway)
- **(RU0588)** - Outside Sports Pavillion – (19 metre clearway)
- **(RU0589)** - Outside number 126 – (19 metre clearway)

The County Council works closely with all public transport operators across the County to identify bus stops that suffer from inconsiderate parking. At the locations listed above, bus stop clearways are to be installed that prohibit other vehicles from parking or waiting in the bus stop at the times specified and these will be clearly identified with new road markings and signage. The main benefits of bus stop clearways are to:

- Help the bus align with the kerb to enable better access for disabled passengers and pushchair users;
- Ease congestion as a correctly aligned bus will not block the road for other road users;
- Ensure that bus drivers discharge their duty to drop passengers off on the kerb and not on the road;
- Ensure that bus services operate on time and are not unnecessarily delayed.

In addition to the above, in order to address concerns of inconsiderate parking which is causing issues with visibility and access, it is also proposed to introduce **No Waiting At Any Time** (Double Yellow Lines) parking restrictions around the junction of Bingham Road and Golf Road.
