

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (GREYTHORN DRIVE, RUGBY ROAD,
UPPINGHAM CRESCENT AND STOW AVENUE, WEST BRIDGFORD) (PROHIBITION OF
WAITING) TRAFFIC REGULATION ORDER 2023 (8357)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at West Bridgford in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Waiting At Any Time** along the following: -

GREYTHORN DRIVE, (WEST BRIDGFORD)

(the north-east side)

- From its junction with Rugby Road in a south-easterly direction for 12 metres

(the south-west side)

- From its junction with Rugby Road in a south-easterly direction for 12 metres
- From a point 19 metres south-east of its junction with Rugby Road in a south-easterly direction for 16 metres

UPPINGHAM CRESCENT, (WEST BRIDGFORD) (both sides)

- From its junction with Stowe Avenue in a north-westerly direction for 10 metres

STOWE AVENUE, (WEST BRIDGFORD)

(the north-west side)

- From a point 10 metres south-west of its junction with Uppingham Crescent in a north-easterly direction to a point 10 metres north-east of that junction
