

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (BRIDGFORD ROAD, FOX ROAD, HOUND ROAD AND SCARRINGTON ROAD, WEST BRIDGFORD) (PROHIBITION OF LOADING) TRAFFIC REGULATION ORDER 2023 (8363)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at West Bridgford in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Loading on Football Event Days, Monday – Friday 6pm – 10pm, Saturday, Sunday & Bank Holidays 10am - 10 pm** along the following lengths of road: -

## BRIDGFORD ROAD, WEST BRIDGFORD(the north-east side)

• From a point 10 metres north-west of its junction with Hound Road in a south-easterly direction to a point 10 metres south-east of that junction.

## FOX ROAD, WEST BRIDGFORD

(the north-east side)

- From its junction with Radcliffe Road in a south-easterly direction for 20 metres
- From a point 160 metres south-east of its junction with Radcliffe Road to its junction with Hound Road.

(the south-west side)

- From its junction with Radcliffe Road in a south-easterly direction for 20 metres
- From a point 160 metres south-east of its junction with Radcliffe Road in a south-easterly direction to its junction with Hound Road

#### HOUND ROAD, WEST BRIDGFORD (both sides)

- From its junction with Bridgford Road in a north-easterly direction for 10 metres
- From its junction with Fox Road in a south-westerly for 20 metres

## SCARRINGTON ROAD, WEST BRIDGFORD

(the east side) - From the entrance to the Environment Agency Depot in southerly direction for 78 metres (the north side) - From its junction with Lady Bay Bridge in south-westerly then north-westerly then westerly direction for 40 metres

(the south side) - From its junction with Lady Bay Bridge in south-westerly then north-westerly then westerly direction for 37 metres

(the west side) - From the entrance to the Environment Agency Depot in southerly direction for 78 metres
