

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (CHATSWORTH ROAD, GERTRUDE ROAD, JULIAN ROAD, PIERREPONT ROAD, RUTLAND ROAD AND SEYMOUR ROAD, WEST BRIDGFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8378)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council **HAS MADE** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at West Bridgford in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Waiting At Any Time** along the following lengths of road: -

# **CHATSWORTH ROAD, WEST BRIDGFORD**

(the east side) - From its junction with Rutland Road in a northerly direction for 9 metres (the north side) - From its junction with Seymour Road in an easterly direction for 10 metres (the south side) - From its junction with Seymour Road in an easterly direction for 10 metres (the west side) - From its junction with Rutland Road in a northerly direction for 8 metres

## **GERTRUDE ROAD, WEST BRIDGFORD**

(the east side) - From its junction with Rutland Road in a northerly direction for 12 metres (the west side) - From its junction with Rutland Road in a northerly direction for 8 metres

## JULIAN ROAD, WEST BRIDGFORD

(the east side) - From its junction with Rutland Road in a northerly direction for 13 metres (the west side) - From its junction with Rutland Road in a northerly direction for 12 metres

## PIERREPONT ROAD, WEST BRIDGFORD

(the east side) - From its junction with Rutland Road in a northerly direction for 13 metres (the west side) - From its junction with Rutland Road in a northerly direction for 11 metres

## RUTLAND ROAD, WEST BRIDGFORD (the north-east side)

- From a point 12 metres north-west of its junction with Pierrepont Road in a south-easterly direction to a point 6 metres south-east of that junction
- From a point 10 metres north-west of its junction with Gertrude Road in a south-easterly direction to a point 8
  metres south-east of that junction
- From a point 12 metres north-west of its junction with Julian Road in a south-easterly direction to a point 16 metres south-east of that junction
- From a point 10 metres north-west of its junction with Seymour Road in a south-easterly direction to a point 10 metres south-east of that junction
- From a point 10 metres north-west of its junction with Chatsworth Road in a south-easterly direction to a point 9 metres south-east of that junction

#### **RUTLAND ROAD, WEST BRIDGFORD**(the south-west side)

• From its junction with the north-east to south-west section of Rutland Road in a north-westerly direction for 13 metres

#### RUTLAND ROAD, WEST BRIDGFORD (north-east to south-west section)

(the north-west side) - From its junction with Rutland Road in a south-westerly direction for 15 metres (the south-east side) - From its junction with Rutland Road in a south-westerly direction for 14 metres

# SEYMOUR ROAD, WEST BRIDGFORD

(the east side) -

- From its junction with Rutland Road in a north-easterly direction for 11 metres
- From a point 10 metres north of its junction with Chatsworth Road in a southerly direction to a point 12 metres south of that junction.

(the west side) - From its junction with Rutland Road in a north-easterly direction for 10 metres
