

THE NOTTINGHAMSHIRE COUNTY COUNCIL (CHURCH STREET, MARKET PLACE AND MARKET STREET, BINGHAM) (PROHIBITION OF WAITING AND PARKING PLACES) TRAFFIC REGULATION ORDER 2024 (8384)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Bingham in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Waiting At Any Time** along the following lengths of road:-

MARKET PLACE NORTH, BINGHAM

- (the north side) - From a point 3 metres east of its junction with Station Street for 3 metres
- (the south side)- From a point 30 metres east of its junction with Market Street in an easterly direction for 20 metres

2. To provide **30-minute parking**, No Return within 1 hour. Operating Mon – Sat 8am – 6pm along the following lengths of road:-

CHURCH STREET, BINGHAM (the south side)

- From its junction with Market Place in an easterly direction for 13 metres

MARKET PLACE NORTH, BINGHAM (the north side)

- From a point 17 metres west of its junction with Station Street in a westerly direction for 17 metres
- From a point 6 metres east of its junction with Station Street in an easterly direction for 15 metres

MARKET PLACE SOUTH, BINGHAM (the south side)

- From its junction with Church Street in a westerly direction for 24 metres
- From a point 29 metres west of its junction with Church Street in a westerly direction for 16 metres

MARKET PLACE NORTH, BINGHAM (the south side)

- From a point 13 metres east of its junction with Market Street in and easterly direction for 17 metres
- From a point 50 metres east of its junction with Market Street in and easterly direction for 27 metres

MARKET STREET, BINGHAM (the west side)

- From a point 7 metres north of a point adjacent to the northern boundary of 1 Market Place in a northerly direction for 17 metres
- From a point 2 metres north of its junction with Union Street in a northerly direction for 11 metres
- From a point 9 metres north of its junction with Long Acre in a northerly direction for 22 metres

3. To provide **3 Hours Disabled vehicle parking**, No Return within 1 hour. Operating Mon – Sat 8am – 6pm along the following lengths of road:-

MARKET STREET, BINGHAM (the west side)

- From a point 1 metre north of a point adjacent to the northern boundary of 1 Market Place in a northerly direction for 6 metres
- From a point 13 metres north of its junction with Unions Street in a northerly direction for 17 metres
