**LANTERN LANE AND SHARPLEY DRIVE, EAST LEAKE – PROPOSED PROHIBITION OF WAITING, SCHOOL KEEP CLEAR MARKINGS AND HUMPED ZEBRA CROSSING (TRO 8385) - PUBLIC ADVERT**

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. Nottinghamshire County Council is proposing to extend the existing traffic calming to install a humped zebra crossing to assist pedestrians in crossing Lantern Lane to access both the primary and secondary schools and leisure centre.

To help facilitate the proposed zebra crossing, it is proposed to install Double Yellow Lines (No Waiting At Any Time) around the junction of Sharpley Drive along with Single Yellow Lines and School Keep Clear Marking (No Stopping Mon – Fri 8 am – 4.30 pm), in the area outside both of the schools and the Leisure Centre, as shown on attached plan.

The proposals are required to make it easier and safer for pedestrians to access the school and Leisure Centre and will help to improve conditions for buses accessing/egressing the school site and will improve visibility at the junctions. Further to the initial consultation letter of 2<sup>nd</sup> July 2024, the next stage of the consultation is to publicly advertise the scheme. The notice will be published in the Nottingham Post and notices will be fixed on site.

Any observations on these proposals should reach me in writing, either by letter or email, by **15<sup>th</sup> October 2024**. If your comments are in the form of an objection to the proposals please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time. Any details you provide may be shared with Nottinghamshire County Council as appropriate.
