

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Keyworth in the Borough of Rushcliffe: -

1. Vehicles will be **Prohibited from Waiting At Any Time** along the following lengths of road: -

**CHURCH DRIVE, KEYWORTH** (both sides)

- From its junction with Nottingham Road in an easterly direction for 10 metres

**FAIRWAY, KEYWORTH**

(the north-east side)

- From its junction with Willow Brook in a north-westerly direction for 16 metres

(the south-west side)

- From its junction with Willow Brook in a north-westerly direction for 13 metres

**NOTTINGHAM ROAD, KEYWORTH**

(the east side)

- From a point 5 metres north of its junction with Church Drive in a southerly direction to a point 10 metres south of that junction

(the west side)

- From a point 6 metres north of its junction with Rose Hill in a southerly direction to a point 10 metres south of that junction

**ROSE HILL, KEYWORTH** (both sides)

- From its junction with Nottingham Road in a westerly direction for 10 metres

**WILLOW BROOK, KEYWORTH** (the north-west side)

- From a point 13 metres north-east of its junction with Fairway in a south-westerly direction to a point 10 metres south-west of that junction

2. Vehicles will be **Prohibited from Waiting Mon – Fri 8am – 4.30pm** along the following lengths of road: -

**WILLOW BROOK, KEYWORTH** (the north-west side)

- From a point 10 metres south-west of its junction with Fairway in south-westerly direction for 35 metres
