

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ABBEY CIRCUS, ABBEY ROAD, CAMBRIDGE ROAD AND OXFORD ROAD, WEST BRIDGFORD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8412)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at West Bridgford in the Borough of Rushcliffe: -

1. **Vehicles will be Prohibited from Waiting At Any Time** along the following lengths of road:-

ABBEY CIRCUS, WEST BRIDGFORD (Section 1) (the north-west side)

- From a point 10 metres south-west of its junction with Oxford Road in a north-easterly direction to a point 10 metres north-east of that junction
- From its junction with Abbey Road in a south-westerly direction for 10 metres

ABBEY CIRCUS, WEST BRIDGFORD (Section 1) (the south-east side)

- From a point 9 metres south-west of its junction with Abbey Circus (Section 3) in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with Abbey Circus (Section 2) in a north-easterly direction to a point 11 metres north-east of that junction
- From its junction with Abbey Road in a south-westerly direction for 10 metres

ABBEY CIRCUS, WEST BRIDGFORD (Section 2) (the north-west side)

- From its junction with Abbey Circus (Section 1) in a south-westerly direction for 10 metres
- From its junction with Cambridge Road in a north-easterly direction for 10 metres

ABBEY CIRCUS, WEST BRIDGFORD (Section 2) (the south-east side)

- From its junction with Abbey Circus (Section 1) in a south-westerly direction for 10 metres
- From its junction with Cambridge Road in a north-easterly direction for 10 metres

ABBEY CIRCUS, WEST BRIDGFORD (Section 3) (the north-east side)

- From its junction with Abbey Circus (Section 1) in a south-easterly direction for 10 metres
- From its junction with Cambridge Road in a north-westerly direction for 10 metres

ABBEY CIRCUS, WEST BRIDGFORD (Section 3) (the south-west side)

- From its junction with Abbey Circus (Section 1) in a south-easterly direction for 10 metres
- From its junction with Cambridge Road in a north-westerly direction for 10 metres

ABBEY ROAD, WEST BRIDGFORD (the south-west side)

- From a point 10 metres south-east of its junction with Abbey Circus (Section 1) in a north-westerly direction to a point 10 metres north-west of that junction

CAMBRIDGE ROAD, WEST BRIDGFORD (the north-east side)

- From its junction with Abbey Circus (Section 2) in a south-westerly direction for 10 metres

CAMBRIDGE ROAD, WEST BRIDGFORD (the south-west side)

- From its junction with Abbey Circus (Section 3) in a south-westerly direction for 10 metres

OXFORD ROAD, WEST BRIDGFORD (both sides)

- From its junction with Abbey Circus (Section 1) in a north-westerly direction for 10 metres
