

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (CHURCH STREET AND LAUNDER STREET,
ORSTON) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8414)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Orston in the Borough of Rushcliffe: -

1. Proposed **Prohibition of Waiting At Any Time** along the following lengths of road: -

CHURCH STREET, ORSTON (the north-west side)

- From a point 11 metres south of its junction with Launder Street in a north-easterly direction to a point 10 metres north-east of that junction

LAUNDER STREET, ORSTON (both sides)

- From its junction with Church Street in a north-westerly direction to for 10 metres

2. Proposed **Prohibition of Waiting Mon - Fri 8 am - 9.30am and 3pm - 4.30 pm** along the following lengths of road:-

CHURCH STREET, ORSTON

(the north-west side)

- From a point 10 metres north-east of its junction with Launder Street in a north-easterly direction for 10 metres

(the south-east side)

- From a point opposite a point 14 metres north-east of its junction with Launder Street in a north-easterly then south-easterly then north-easterly direction for 16 metres

3. Proposed **Bus Stop Clearway – No Stopping Mon - Fri 8 am - 9.30am and 3pm - 4.30 pm except buses** along the following length of road: -

CHURCH STREET, ORSTON (the south-east side)

- From a point opposite a point 2 metres north-east of its junction with Launder Street in a north-easterly direction for 12 metres
