

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ABBEY ROAD AREA, BINGHAM)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2025 (8415)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Bingham in the Borough of Rushcliffe: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

ABBEY ROAD, BINGHAM (both sides)

- From its junction with Nursery Road in a north-westerly direction for 10 metres.

ABBEY ROAD, BINGHAM (the north-east side)

- From a point 10 metres north-west of its junction with Brownes Road in a south-easterly direction to a point 10 metres south-east of that junction.
- From a point 10 metres north-west of its junction with Victoria Road in a south-easterly direction to a point 10 metres south-east of that junction.

BROWNES ROAD, BINGHAM (both sides)

- From its junction with Abbey Road in a north-easterly direction for 10 metres.

NURSERY ROAD, BINGHAM (the north-west side)

- From a point 10 metres north-east of its junction with Abbey Road in a south-westerly direction to a point 10 metres south-west of that junction.

VICTORIA ROAD, BINGHAM (both sides)

- From its junction with Abbey Road in a north-easterly direction for 10 metres.
