

<u>THE NOTTINGHAMSHIRE COUNTY COUNCIL</u> (REDCLIFFE ROAD AREA, MANSFIELD) (PROHIBITION OF WAITING) <u>TRAFFIC REGULATION ORDER 2025 (2272)</u>

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Mansfield in the District of Mansfield: -

Proposed prohibition of Waiting At Any Time along the following length of road: -

Bowling Street, Mansfield (east side)

• From a point 10 metres north-west of its junction with Hope Street in a south-easterly direction then southwesterly direction to a point 10 metres south-west of that junction.

Broxtowe Drive, Mansfield (south-east side)

- From a point 10 metres north-east of its junction with Prospect Street in a south-westerly direction to a point 10 metres south-west of that junction.
- Coronation Street, Mansfield (both sides)

• From its junction with Redcliffe Road in a south easterly direction for 10 metres **Empire Street, Mansfield** (both sides)

• From its junction with Redcliffe Road in a south easterly direction for 10 metres **Hope Street, Mansfield** (both sides)

• From its junction with Bowling Street in a south easterly direction for 10 metres

Prospect Street, Mansfield (both sides)

• From its junction with Broxtowe Drive in a south easterly direction for 10 metres **Ratcliffe Gate, Mansfield** (north-east side)

• From its junction with Redcliffe Road in a north westerly direction for 10 metres **Redcliffe Road, Mansfield (**south-east side)

- From a point 10 metres north-east of its junction with Coronation Street in a south-westerly direction to a point 10 metres south-west of that junction
- From a point 63 metres north-east of its junction with Empire Street in a south-westerly direction to a point 10 metres south-west of that junction
- From its junction with Rock Hill in a north-easterly direction for 10 metres
- Redcliffe Road, Mansfield (north-west side)
- From its junction with Ratcliffe Gate in a north-easterly direction for 10 metres
- Rock Hill, Mansfield (north-east side)
 - From its junction with Redcliffe Road in a south-easterly direction for 3 metres
