

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (OLLERTON ROAD, WELBECK ROAD AND WHARNCLIFFE ROAD, RETFORD) (PROHIBITION OF WAITING AND PARKING PLACES) TRAFFIC REGULATION ORDER 2024 (1297)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council **Has Made** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Retford in the District of Bassetlaw: -

1. Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

#### **OLLERTON ROAD, RETFORD** (the east side)

• From a point opposite a point 10 metres north of its junction with Welbeck Road in a southerly direction for 26 metres.

### <u>WELBECK ROAD, RETFORD</u> (the north and south side)

• From its junction with Ollerton Road in a westerly direction for 16 metres

#### WELBECK ROAD, RETFORD (the north-west side)

• From its junction with Wharncliffe Road in a south-westerly direction for 13 metres

### WHARNCLIFFE ROAD, RETFORD (the north-east side)

From its junction with Welbeck Road in a north-westerly direction for 20 metres

#### WHARNCLIFFE ROAD, RETFORD (the south-west side)

- From its junction with Welbeck Road in a north-westerly direction for 15 metres
- 2. **Limited Waiting Parking Bay** Mon-Sat 8am-6pm, 1-hour maximum wait and no return within 1 hour along the following lengths of road: -

#### WELBECK ROAD, RETFORD (the south side)

- From a point 16 metres west of its junction with Ollerton Road in a westerly direction for 13 metres
- From a point 36 metres west of its junction with Ollerton Road in a westerly direction for 15 metres
