

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (GATEFORD PRIMARY SCHOOL AREA, WORKSOP) (PROHIBITION OF WAITING AND NO STOPPING ON ENTRANCE CLEARWAY) TRAFFIC REGULATION ORDER 2024 (1302)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Worksop in the District of Bassetlaw: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

# AZURE PLACE, WORKSOP (both sides)

From its junction with Gatekeeper Way in a north-easterly direction for 10 metres

# **CHURCHILL WAY, WORKSOP** (both sides)

From its junction with Harlequin Drive in a south-easterly direction for 10 metres

# **GATEKEEPER WAY, WORKSOP** (the north-east side)

- From its junction with Harlequin Drive in a north-westerly direction for 10 metres
- From a point 10 metres south-east of its junction with Azure Place in a north-westerly direction to a point 10 metres north-west of that junction.
- From a point 50 metres south-east of its junction with Orange Tip Close in a south-easterly direction for 10 metres
- From a point 10 metres south-east of its junction with Orange Tip Close in a north-westerly direction to a point 10 metres north-west of that junction.

# **GATEKEEPER WAY, WORKSOP** (the south-west side)

- From its junction with Harlequin Drive in a north-westerly direction for 14 metres
- From a point opposite a point 50 metres south-east of its junction with Orange Tip Close in a south-easterly direction for 10 metres
- From a point 10 metres south-east of its junction with Holly Blue Way in a north-westerly direction to a point 10 metres north-west of that junction

# **HARLEQUIN DRIVE, WORKSOP** (the north-west side)

• From a point 23 metres south-west of its junction with Gatekeeper Way in a north-easterly direction to a point 10 metres north-east of that junction

#### **HARLEQUIN DRIVE, WORKSOP** (the south-east side)

- From a point 10 metres south-west of its junction with Churchill Way in a north-easterly direction to a point 10 metres north-east of that junction
- From a point 10 metres south-west of its junction with Red Admiral Road in a north-easterly direction to a point 25 metres north-east of that junction

# **HOLLY BLUE WAY, WORKSOP** (both sides)

From its junction with Gatekeeper Way in a south-westerly direction for 10 metres

#### **ORANGE TIP CLOSE, WORKSOP** (both sides)

• From its junction with Gatekeeper Way in a north-easterly direction for 10 metres

# RED ADMIRAL ROAD, WORKSOP (both sides)

- From its junction with Harlequin Drive in a south-easterly direction for 10 metres
- 2. Proposed prohibition of Waiting Mon-Fri 8am-4.30pm along the following lengths of road: -

# **GATEKEEPER WAY, WORKSOP** (the south-west side)

- From a point opposite a point 32 metres south-east of its junction with Azure Place in a north-westerly direction for 36 metres
- 3. Proposed **prohibition of Stopping on Entrance Clearways Mon-Fri 8am-4.30pm** along the following lengths of road: -

### **GATEKEEPER WAY, WORKSOP** (the south-west side)

• From a point opposite a point 40 metres north-west of its junction with Azure Place in a southeasterly direction for 44 metres
