

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ELM TREE STREET, GOODACRE STREET AND PELHAM STREET, MANSFIELD) (PROHIBITION OF WAITING AND PARKING PLACES) TRAFFIC REGULATION ORDER 2023 (2265)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Mansfield in the District of Mansfield: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

ELM TREE STREET, MANSFIELD (the north-west side)

• From its junction with Pelham Street in a south-westerly direction for 10 metres

GOODACRE STREET, MANSFIELD (both sides)

• From its junction with Pelham Street in a north-easterly direction for 10 metres

PELHAM STREET, MANSFIELD (the north-east side)

- From a point 7 metres south-east of its junction with Goodacre Street in a north-westerly direction to a point 17 metres north-west of that junction
- From a point 8 metres south-east of its junction with Recreation Street in a north-westerly direction up to and including its north-western extremity

PELHAM STREET, MANSFIELD (the south-west side)

- From its junction with Elm Tree Street in a north-westerly direction for 7 metres
- 2. Proposed prohibition of Waiting Mon-Sat 8am 6.30pm along the following lengths of road: -

PELHAM STREET, MANSFIELD (the north-east side)

- From a point 29 metres north-west of its junction with Newgate Lane in a north-westerly direction for 10 metres
- From a point 7 metres south-east of its junction with Goodacre Street in a south-easterly direction for 32 metres
- From a point 17 metres north-west of its junction with Goodacre Street in a north-westerly direction for 29 metres

PELHAM STREET, MANSFIELD (the south-west side)

- From a point 15 metres north-west of its junction with Newgate Lane in a north-westerly direction for 135 metres
- From its junction with Elm Tree Street in a south-easterly direction for 7 metres
- From a point 7 metres north-west of its junction with Elm Tree Street in a north-westerly direction to its north-western extremity

3. Proposed **30-minute parking bays**, No Return within 1 hour. Operating Mon – Sat 8am – 6.30pm along the following lengths of road: -

ELM TREE STREET, MANSFIELD (the north-west side)

• From a point 42 metres north-east of its junction with Radcliffe Gate in a north-easterly direction for 32 metres

PELHAM STREET, MANSFIELD (the north-east side)

- From a point 15 metres north-west of its junction with Newgate Lane in a north-westerly direction for 14 metres
- From a point 39 metres north-west of its junction with Newgate Lane in a north-westerly direction for 40 metres

PELHAM STREET, MANSFIELD (the south-west side)

• From a point 7 metres south-east of its junction with Elm Tree Street in a south-easterly direction for 11 metres
