

THE NOTTINGHAMSHIRE COUNTY COUNCIL (NABBS LANE AREA, HUCKNALL)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (4286)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Hucknall in the District of Ashfield: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

BRETT CLOSE, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 10 metres

BABBACOMBE WAY, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 14 metres

ELIZABETH CLOSE, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 10 metres

GODBER ROAD, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 10 metres

NABBS LANE, HUCKNALL (The north-east side)

- From its junction with Watnall Road in a north-westerly direction for 59 metres

NABBS LANE, HUCKNALL (The south-west side)

- From a point 41 metres north-west of its junction with Watnall Road in a north-westerly direction to a point 10 metres north-west of its junction with Brett Close
- From a point 10 metres south-east of its junction with Godber Road in a north-westerly direction to a point 10 metres north-west of that junction
- From a point 10 metres south-east of its junction with Elizabeth Close in a north-westerly direction to a point 10 metres north-west of that junction
- From a point 10 metres south-east of its junction with Strathmore Close in a north-westerly direction to a point 10 metres north-west of that junction
- From a point 10 metres south-east of its junction with Rushcliffe Road in a north-westerly direction to a point 10 metres north-west of that junction
- From a point 12 metres south-east of its junction with Babbacombe Way in a north-westerly direction to a point 14 metres north-west of that junction

RUFFS DRIVE, HUCKNALL

- (The north-east side) From its junction with Watnall Road in a north-westerly direction for 43 metres
- (The south-west side) From its junction with Watnall Road in a north-westerly direction for 54 metres

RUSHCLIFFE ROAD, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 10 metres

STRATHMORE CLOSE, HUCKNALL

- (both sides) From its junction with Nabbs Lane in a south-westerly direction for 10 metres

WATNALL ROAD, HUCKNALL

- (The north-west side) From a point 10 metres south-west of its junction with Ruffs Drive in a north-easterly direction to a point 10 metres north-east of that junction

2. Other Restrictions – **Bus Stop Clearway** - No Stopping at Any Time except buses

NABBS LANE, HUCKNALL

- (The north-east side) From a point 59 metres north-west of its junction with Watnall Road in a north-westerly direction for 19 metres.
