

THE NOTTINGHAMSHIRE COUNTY COUNCIL (ALFRETON ROAD, MAPPLEWELLS CRESCENT AND MAPPLEWELLS ROAD, SUTTON-IN-ASHFIELD) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (4287)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Sutton-in-Ashfield in the District of Ashfield: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

ALFRETON ROAD, SUTTON-IN-ASHFIELD (the north-west side)

- From a point 10 metres south-west of its junction with Mapplewells Road in a north-easterly direction to a point 13 metres north-east of that junction

MAPPLEWELLS CRECENT, SUTTON-IN-ASHFIELD (the north-west side)

- From its junction with Mapplewells Road in a south-westerly direction for 12 metres

MAPPLEWELLS CRECENT, SUTTON-IN-ASHFIELD (the south-east side)

- From its junction with Mapplewells Road in a south-westerly direction for 13 metres

MAPPLEWELLS ROAD, SUTTON-IN-ASHFIELD (the north-east side)

- From its junction with Alfreton Road in a north-westerly direction for 11 metres

MAPPLEWELLS ROAD, SUTTON-IN-ASHFIELD (the south-west side)

- From its junction with Alfreton Road in a north-westerly direction for 11 metres
- From a point 13 metres south-east of its junction with Mapplewells Crescent in a north-westerly direction to a point 16 metres north-west of that junction
