

**THE NOTTINGHAMSHIRE COUNTY COUNCIL (BROOMHILL FARM AREA, HUCKNALL)
(PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (4293)**

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Hucknall in the District of Ashfield: -

1. Proposed **prohibition of Waiting At Any Time** along the following lengths of road: -

HANOVER COURT, (HUCKNALL) (both sides)

- From its junction with Jackson Road in a south-easterly direction for 9 metres

HANOVER COURT, (HUCKNALL) (the south-eastern extremity turning head)

- From a point 44 metres south-east of its junction with Jackson Road around the entire turning head for 65 metres.

JACKSON ROAD, (HUCKNALL) (the north-west side)

- From a point 26 metres north-east of its junction with Westminster Way in a south-westerly direction to a point 10 metres south-west of that junction.
- From a point 17 metres north-east of its junction with Road 5 in a south-westerly direction to a point 10 metres south-west of that junction.

JACKSON ROAD, (HUCKNALL) (the south-east side)

- From a point opposite a point 26 metres north-east of its junction with Westminster Way in a south-westerly direction for 48 metres.
- From a point 11 metres north-east of its junction with Hanover Court in a south-westerly direction to a point 9 metres south-west of that junction.
- From a point 10 metres north-east of its junction with Kensington Gardens in a south-westerly direction to a point 10 metres south-west of that junction.

JACKSON ROAD, (HUCKNALL) (the south-western extremity turning head)

- From a point 93 metres south-west of its junction with Kensington Gardens around the entire turning head for 62 metres

KENSINGTON GARDENS, (HUCKNALL) (the north-east side)

- From its junction with Jackson Road in a south-easterly direction for 10 metres

KENSINGTON GARDENS, (HUCKNALL) (the north-west side)

- From a point 200 metres from its junction with Jackson Road in a south-westerly direction for 11 metres

KENSINGTON GARDENS, (HUCKNALL) (the south-east side)

- From a point 195 metres from its junction with Jackson Road in a south-westerly direction up to and including its south-western extremity and its south-eastern turning head.

KENSINGTON GARDENS, (HUCKNALL) (the south-west side)

- From its junction with Jackson Road in a south-easterly direction for 10 metres

ROAD 2, (HUCKNALL) (the north-west side)

- From a point 10 metres north-east of its junction with Road 3 in a south-westerly direction to a point 10 metres south-west of that junction
- From a point 150 metres from its junction with Road 5 in a north-easterly direction up to and including its north-eastern extremity, and its north-western turning head

ROAD 2. (HUCKNALL) (the south-east side)

- From a point 10 metres north-east of its junction with Westminster Way in a south-westerly direction to a point 10 metres south-west of that junction
- From its north-eastern extremity turning head in a south-westerly direction for 9 metres
- From a point 10 metres north-east of its junction with Road 5 in a south-westerly direction to a point 10 metres south-west of that junction

ROAD 3. (HUCKNALL) (the north-east side)

- From its junction with Road 2 in a north-westerly direction for 10 metres
- From a point 40 metres north-west of its junction with Road 2 in a north westerly direction up to and including its north-western extremity, including its north-eastern extremity turning head.

ROAD 3. (HUCKNALL) (the south-west side)

- From its junction with Road 2 in a north-westerly direction for 10 metres

ROAD 5. (HUCKNALL) (both sides)

- From its junction with Jackson Road in a north-westerly direction for 10 metres
- From its junction with Road 2 in a south-easterly direction for 10 metres

WESTMINSTER WAY. (HUCKNALL) (both sides)

- From its junction with Jackson Road in a north-westerly direction for 10 metres
- From its junction with Road 2 in a south-easterly direction for 10 metres
