

THE NOTTINGHAMSHIRE COUNTY COUNCIL (CHETWYND ROAD, MARTON ROAD AND THOMPSON CLOSE, CHILWELL) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (5337)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be in respect of roads at Chilwell in the Borough of Broxtowe: -

1. Proposed prohibition of Waiting At Any Time along the following lengths of road: -

CHETWYND ROAD, (CHILWELL) (the north-west side)

 From a point 10 metres south-west of its junction with Marton Road in a north-easterly direction to a point 10 metres north-east of that junction

<u>CHETWYND ROAD, (CHILWELL)</u> (the south-east side)

• From a point 12 metres south-west of its junction with Thompson Close in a north-easterly direction to a point 16 metres north-east of that junction

MARTON ROAD, (CHILWELL) (both sides)

From its junction with Chetwynd Road in a north-westerly direction for 10 metres

THOMPSON CLOSE, (CHILWELL) (the north-east side)

• From its junction with Chetwynd Road in a south-easterly direction for 15 metres

THOMPSON CLOSE, (CHILWELL) (the south-west side)

From its junction with Chetwynd Road in a south-easterly direction for 17 metres
