



**THE NOTTINGHAMSHIRE COUNTY COUNCIL (LONG LANE,  
ATTENBOROUGH) (PROHIBITION OF WAITING) TRAFFIC REGULATION  
ORDER 2025 (5355)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Attenborough in the Borough of Broxtowe: -

1. **PROPOSED PROHIBITION OF WAITING AT ANY TIME** along the following lengths of road: -

**Long Lane, Attenborough (The West Side)**

- From its junction with Clifton Crescent in a Northerly direction for 90 metres
2. **PROPOSED BUS STOP CLEARWAY - No Stopping at any time except for buses** along the following lengths of road:

**Long Lane, Attenborough (The West Side)**

- From a point 70 metres north of its junction with Clifton Crescent in a northerly direction for 19 metres.

**Long Lane, Attenborough (The East Side)**

- From a point 9 metres south of its junction with Meadow Lane in a southerly direction for 19 metres.
