

# THE NOTTINGHAMSHIRE COUNTY COUNCIL (CURZON STREET AREA, NETHERFIELD – VARIOUS LOCATIONS) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2023 (7252)

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council **Has Made** an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Netherfield in the Borough of Gedling: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

### Asper Street, Netherfield (north-east side)

- From its junction with Curzon Street in a south-easterly direction for 10 metres.
- From its junction with Dunstan Street in a north-westerly direction for 10 metres.

## <u>Asper Street, Netherfield</u> (south-west side)

- From its junction with Curzon Street in a south-easterly direction for 10 metres.
- From its junction with Dunstan Street in a north-westerly direction for 10 metres.

# <u>Cross Street, Netherfield</u> (north-east side)

From its junction with Curzon Street in a south-easterly direction for 10 metres.

# <u>Cross Street, Netherfield</u> (south-west side)

• From its junction with Curzon Street in a south-easterly direction for 10 metres.

### Curzon Street, Netherfield (south-east side)

- From a point 10 metres south-west of its junction with Cross Street in a north-easterly direction to a point 10 metres north-east of that junction.
- From a point 10 metres south-west of its junction with Asper Street in north-easterly direction to a point 10 metres north-east of that junction.

### <u>Dunstan Street, Netherfield</u> (north-west side)

• From a point 10 metres south-west of its junction with Asper Street in a north-easterly direction to a point 10 metres north-east of that junction.
