

THE NOTTINGHAMSHIRE COUNTY COUNCIL (RAMBLERS CLOSE AND VARIOUS JUNCTIONS ON CROSSLANDS MEADOW, COLWICK) (PROHIBITION OF WAITING) TRAFFIC REGULATION ORDER 2024 (7270)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council Has Made an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be, in respects of roads at Colwick in the Borough of Gedling: -

Vehicles will be prohibited from Waiting At Any Time along the following lengths of road: -

- 1. CROSSLANDS MEADOW (COLWICK) The east side
 - (i) From a point 9 metres north of its junction with Egling Croft in a southerly direction to a point 10 metres south of the same junction.
 - (ii) From a point 10 metres north of its junction with Fox Covert in a southerly direction to a point 10 metres south of the same junction.
- 2. CROSSLANDS MEADOW (COLWICK) The north-east side
 - (i) From a point 10 metres north-west of its junction with Little Ox in a south-easterly direction to a point 10 metres south-east of the same junction.
- 3. CROSSLANDS MEADOW (COLWICK) The west side
 - (i) From a point 10 metres north of its junction with Ozier Holt in a southerly direction to a point 7 metres south of the same junction.
 - (ii) From a point 10 metres north of its junction with Parsons Meadow in a southerly direction to a point 10 metres south of the same junction.
- 4. CROSSLANDS MEADOW (COLWICK) The south-west side
 - (i) From a point 7 metres north-west of its junction with Swan Meadow in a south-easterly direction to a point 10 metres south-east of the same junction.
- 5. <u>EGLING CROFT (COLWICK) The north-west side</u>
 - (i) From its junction with Crosslands Meadow in a north-easterly direction for 10 metres.
- 6. EGLING CROFT (COLWICK) The south-east side
 - (i) From its junction with Crosslands Meadow in a north-easterly direction for 9 metres.
- 7. FOX COVERT (COLWICK) Both sides
 - From its junction with Crosslands Meadow in an easterly direction for 10 metres.
- 8. <u>LITTLE OX (COLWICK) The north-west side</u>
 - (i) From its junction with Crosslands Meadow in a north-easterly direction for 11 metres.
- 9. <u>LITTLE OX (COLWICK) The south-east side</u>
 - (i) From its junction with Crosslands Meadow in a north-easterly direction for 10 metres.
- 10. PARSONS MEADOW (COLWICK) Both sides
 - (i) From its junction with Crosslands Meadow in a westerly direction for 5 metres.
- 11. POOL MEADOW (COLWICK) Both sides
 - (i) From its junction with Crosslands Meadow in a south-easterly direction for 8 metres.
- 12. RAMBLERS CLOSE (EAST TO WEST SECTION)(COLWICK) Both sides
 - (i) From its junction with the North-South section of Ramblers Cl in a westerly direction for 6 metres.
- 13. RAMBLERS CLOSE (NORTH TO SOUTH SECTION)(COLWICK) The west side
 - (i) From a point 10 metres north of its junction with Mile End Rd in a northerly direction for 57m.
- 14. <u>SWAN MEADOW (COLWICK) Both sides</u>
 - (i) From its junction with Crosslands Meadow in a south-westerly direction for 10 metres.
