

**The Nottinghamshire County Council (Various Roads in Mapperley and Woodthorpe)(Prohibition of Waiting) Traffic Regulation Order 2017 (7196)**

**NOTICE IS HEREBY GIVEN** that the Nottinghamshire County Council, with the agreement of Nottingham City Council, proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Mapperley and Woodthorpe in the Borough of Gedling and the City of Nottingham:-

**Proposed No waiting at any time restrictions (double yellow lines) at the following locations:-**

1. **CENTRAL AVENUE (MAPPERLEY) (both sides)**  
from its junction with Plains Road in a south-easterly direction for a distance of 21 metres.
2. **FERNLEIGH AVENUE (MAPPERLEY)(both sides)**  
from its junction with Westdale Lane West in a south-westerly direction for a distance of 10 metres.
3. **HAYWOOD ROAD (MAPPERLEY)(both sides)**  
from its junction with Porchester Road in a north-easterly direction for a distance of 10 metres.
4. **KENRICK ROAD (MAPPERLEY) (the north-west side)**  
from a point 7 metres north-east of its junction with Porchester Road (the boundary of the City Council and County Council) in a north-easterly direction for a distance of 3 metres.
5. **KENRICK ROAD (MAPPERLEY) (the south-east side)**  
from a point 4 metres north-east of its junction with Porchester Road (the boundary of the City Council and County Council) in a north-easterly direction for a distance of 6 metres.
6. **NEWBURY CLOSE (WOODTHORPE) (both sides)**  
from its junction with Plains Road in a north-westerly direction for a distance of 6 metres.
7. **PLAINS ROAD (MAPPERLEY) (the south-east side)**  
from its junction with Central Avenue in a south-westerly direction for a distance of 18 metres.
8. **PLAINS ROAD (WOODTHORPE) (the north-west side)**
  - (i) from its junction with Newbury Close in a south-westerly direction for 10 metres.
  - (ii) from its junction with Somersby Road in a south-westerly direction for 10 metres.
9. **PORCHESTER ROAD (MAPPERLEY) (the north-east side)**  
from a point 10 metres north-west of its junction with Haywood Road in a south-easterly direction to a point 10 metres south-east of the same junction.
10. **ROSELEIGH AVENUE (MAPPERLEY) (both sides)**  
from its junction with Westdale Lane West in a south-westerly direction for a distance of 10 metres.
11. **SOMERSBY ROAD (WOODTHORPE) (both sides)**  
from its junction with Plains Road in a north-westerly direction for a distance of 26 metres.
12. **WESTDALE LANE WEST (MAPPERLEY) (the south-west side)**
  - (i) from a point 10 metres north-west of its junction with Roseleigh Avenue in a south-easterly direction to a point 10 metres south-east of the same junction.
  - (ii) from its junction with Fernleigh Avenue in a north-westerly direction for 10 metres.

13. **KENRICK ROAD (MAPPERLEY) (the north-west side)**  
from its junction with Porchester Road in a north-easterly direction to the boundary between the City Council and County Council, a distance of 7 metres.
14. **KENRICK ROAD (MAPPERLEY) (the south-east side)**  
from its junction with Porchester Road in a north-easterly direction to the boundary between the City Council and County Council, a distance of 4 metres.
15. **PORCHESTER ROAD (MAPPERLEY) (the north-east side)**  
from a point 10 metres north-west of its junction with Kenrick Road in a south-easterly direction to a point 10 metres south-east of the same junction.

The double yellow lines are being introduced to remove parked vehicles from the junctions described above. The restrictions will give an obstructed view for vehicles turning into or out of the junctions and allow pedestrians to cross the road without having to negotiate parked vehicles.
