VICTORIA ROAD, KIRKBY-IN-ASHFIELD (EAST OF HAMPDEN STREET) - PROPOSED ZEBRA CROSSING WITH RAISED PLATEAU CROSSING - PUBLIC ADVERT

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. Nottingham County Council have received requests to install a humped zebra crossing on Victoria Road, Kirkby-in-Ashfield, due east of the crossroads with Hampden Street and Lime Tree Avenue.

It is therefore proposed to install a zebra crossing, increasing the safety of pedestrians crossing the road to access facilities and to reduce traffic speeds on approaches to the proposed crossing.

The zebra crossing will have a controlled area, indicated by zig-zag markings, along the carriageway where stopping, parking and loading will be prohibited.

As required under Section 23 of the Road Traffic Regulation Act 1984 (zebra crossing with raised plateau), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the zebra crossing on Victoria Road, Kirkby-In-Ashfield.

Further to the initial consultation letter of the 25th November 2024, the next stage of the consultation is to publicly advertise the scheme. The advert will be published in the Mansfield and Ashfield Chad and notices will be fixed on site. A plan showing the extents of the 'No Stopping or No Loading At Any Time' restrictions (Zig-Zag lines) is attached (Drawing Number 2450120-VIA-HGN-ZZ-DR-CH-0001) along with a copy of the site notice.

Any observations on these proposals should reach me in writing, either by letter or email, by **the 5th February 2025**. If your comments are in the form of an objection to the proposals, please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
