**VILLAGE STREET, EDWALTON - PROPOSED ZEBRA CROSSING - PUBLIC ADVERT**

Via East Midlands Ltd is working on behalf of Nottinghamshire County Council to deliver highway services in Nottinghamshire. Nottinghamshire County Council have received requests to install a zebra crossing on Village Street, Edwalton, west of Village Close with the aim to assist pedestrians crossing the road to access local amenities and Edwalton Primary School.

It is therefore proposed to install a zebra crossing, increasing the safety of pedestrians crossing the road to access the shops and for school children on their way to and from Edwalton Primary School.

As required under Section 23 of the Road Traffic Regulation Act 1984 (zebra crossing), I hereby enclose for your attention the statutory public notice stating the County Council's intention to introduce the zebra crossing on Village Street, Edwalton.

Further to the initial consultation letter of the 18<sup>th</sup> November 2024, the next stage of the consultation is to publicly advertise the scheme. The advert will be published in the Nottingham Post and notices will be fixed on site. A plan showing the extents of the 'No Stopping or No Loading At Any Time' restrictions (Zig-Zag lines) is attached (Drawing Number 2450348-VIA-HGN-ZZ-DR-CH-003) along with a copy of the site notice.

Any observations on these proposals should reach me in writing, either by letter or email, by the **15<sup>th</sup> January 2025**. If your comments are in the form of an objection to the proposals, please clearly state this and the reasons for your objection. If the objection cannot be resolved, it will be reported through the County Council's procedures at the appropriate time.
