

The Nottinghamshire County Council (Acacia Crescent, Westdale Lane East, Carlton and Chestnut Grove, Gedling)(Prohibition of Waiting) Traffic Regulation Order 2017 (7188)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council proposes to make an Order under the Road Traffic Regulation Act 1984, as amended, Traffic Management Act 2004, as amended, and The Civil Enforcement of Parking Contraventions (County of Nottinghamshire) Designation Order 2008 (SI 2008 No. 1086), as amended, the effects of which will be to roads in Carlton and Gedling in the Borough of Gedling:-

1. to prohibit waiting at any time at the following locations,

(i) ACACIA CRESCENT (CARLTON) (the north-west side)

from its junction with Westdale Lane East in a south-westerly direction for a distance of 32 metres.

(ii) ACACIA CRESCENT (CARLTON) (the south-east side)

from its junction with Westdale Lane East in a south-westerly direction for a distance of 10 metres.

(iii) BURLINGTON ROAD (CARLTON) (both sides)

from its junction with Westdale Lane East in a south-westerly direction for a distance of 16 metres.

(iv) CHESTNUT GROVE (GEDLING) (both sides)

from its junction with Westdale Lane East in a north-easterly direction for a distance of 10 metres.

(v) WESTDALE LANE EAST (CARLTON) (the north-east side)

from a point 10 metres north-west of its junction with Chestnut Grove in a south-easterly direction to a point 10 metres south-east of the same junction.

(vi) WESTDALE LANE EAST (CARLTON) (the south-west side)

from a point 10 metres north-west of its junction with Acacia Crescent in a south-easterly direction to a point 10 metres south-east of the same junction.

(vii) WESTDALE LANE EAST (CARLTON) (the south-west side)

from a point 14 metres north-west of its junction with Burlington Road in a south-easterly direction to a point 15 metres south-east of the same junction.

2. to prohibit waiting on Monday to Saturday between 8am – 6pm at the following location

(i) ACACIA CRESCENT (CARLTON) (the south-east side)

from a point 10 metres south-west of its junction with Westdale Lane East in a south-westerly direction for a distance of 24 metres.

3. Other Restrictions – Bus Stop Clearways – No stopping, except buses, at any time

(i) <u>WESTDALE LANE EAST (CARLTON)</u> – outside Post Office Sorting Office and outside Westdale Lane Surgery.

The proposed double yellow lines are intended to keep the road clear of parked vehicles. The removal of parked vehicles will keep the junctions clear to allow pedestrians an unobstructed route across the road and will also give vehicles a clearer view when turning in or out. The parking restrictions on Acacia Crescent will allow better access for larger vehicles, such as refuse lorries and lorries accessing the post office depot.
